TERMS

1. GENERALLY

The Western Colorado Latino Chamber of Commerce (“WCLCC”) reserves the right to remove any job posting or resumes (Advertisements) that, in its discretion, appears discriminatory, unethical or otherwise unlawful, but assumes no duty to do so. Appearance of Advertisements in publications and web pages of the WCLCC does not constitute an endorsement or recommendation by the WCLCC of the goods or services offered therein. Advertisers (“You” or “Your”) are responsible for the editorial content of these Advertisements.

WCLCC encourages You to answer all responses You receive to Advertisements appearing in these pages. While WCLCC regrets any failure to respond to You, WCLCC does not and cannot control or monitor the degree of response, which is entirely at Your discretion.

The WCLCC cannot give out any more information about the Advertisements than what is displayed in the Advertisement itself.

2. USER CONTENT

You acknowledge and agree that You are solely responsible for the form, content and accuracy of any Advertisement or material contained therein placed by You on the WCLCC website (“WCLCC Site”).

- provides instructional information about illegal activities or other activities prohibited by these Terms, including without limitation, making or buying illegal weapons, violating someone's privacy, providing or creating computer viruses or pirating any media; and
- solicits passwords or personal identifying information from other Users.

Any Advertisement You submit must describe You. Examples of inappropriate and prohibited Advertisements include, but are not limited to, Profiles that purport to represent an animal, place, inanimate object, fictional character, or real individual that is not You.

3. IDENTIFICATION OF AGENT TO RECEIVE NOTIFICATION AND ELEMENTS OF NOTIFICATION OF CLAIMED COPYRIGHT OR TRADEMARK INFRINGEMENT

No waiver of any term of these Terms shall be deemed a further or continuing waiver of such term or any other term. In addition, WCLCC's failure to enforce any term of these Terms shall not be deemed as a waiver of such term or otherwise affect WCLCC's ability to enforce such term at any point in the future. Except as expressly provided in an additional agreement, additional Terms for certain areas of the WCLCC Site, a particular "Legal Notice," or software license or material on particular pages on the WCLCC Site, these Terms constitute the entire
